SAFETY IS AN ATTITUDE – GET A GOOD ONE; YOUR LIFE DEPENDS ON IT.

Chapter N Safety Article – April 2007 – By Wayne Gargus, Chapter Educator

“WHAT IF” Have you ever thought seriously about what you should do in various emergency situations? Forethought about what to do in driving and riding situations can save your life, so let’s play a little “what if” game and discuss each one.

1. **What if** you are involved in an accident and you did not fasten your seat belt?
 - Driver ejected from vehicle and killed in rollover accident. Sound familiar?
2. **What if** you run off the roadway onto the shoulder or median?
 - Vehicle rolls several times after skidding on the shoulder.
 - Vehicle sliding out of control crosses the median striking an oncoming 18 wheeler.
3. **What if** a deer suddenly runs from the woods heading toward you?
 - Deer crashes through windshield of a car seriously injuring 4 people.
 - Deer causes motorcycle crash. Deer did not survive, rider seriously injured.
4. **What if** you are cruising down the Interstate with cruise control set and it starts raining?
 - Car hydroplanes out of control causing 10 vehicle pile-up.
 - Motorcycle trike hydroplanes, rolls across median into oncoming traffic.
5. **What if** you see a vehicle coming at you traveling in the wrong lane?
 - Car strikes 18 wheeler head on while traveling in the wrong lane.
6. **What if** you come over a hill and a car is across the road requiring you to make a panic stop?
 - You do not have ABS brakes. You do have ABS brakes. Or do you even know?
7. **What if** you are approaching a vehicle with it’s left turn signal on?
 - A woman in Kansas makes a left turn in front of a motorcycle, killing the rider and co-rider. She pleads no contest to a charge of “failing to yield the right of way.” Her penalty? A \$60 fine and \$117 in court cost.
 - A man in Wisconsin makes a left turn in front of a motorcycle killing the rider and co-rider. Two riders are dead and he pays less than \$200 in fines and court cost.
 - A woman in Michigan pulls away from a stop sign into the path of a M/C killing the rider. She’s charged with negligent homicide but in a plea bargain, will likely face nothing more than probation. (All 3 of the above from AMA Magazine April 2007)
8. **What if** the vehicle directly ahead of you suddenly makes a panic stop? Can you stop in time?
 - Two vehicle crash on hwy 431 injures 4 during heavy rain.
9. **What if** someone is following too closely behind you? Or do you even know the car is there?
 - Without slowing down, tap your brake lights, turn on your emergency flashers, or if neither works, slow gradually to encourage the other driver to pass you. As a last resort, turn into a business location or onto another road.
10. **What if** you observe another driver applying makeup, reading a map, reading a book, yelling at kids in the car, displaying signs of road rage and reacting to another driver in front of you?

We’ll discuss each of the above 10 “what if’s” at the April Chapter Gathering, but when is a better time to actually think of these and many other situations you might encounter while driving or riding your Gold Wing? While driving or riding down the roadways of course. There are always many moments of silence as you travel and we constantly encounter “close calls” or situations that could have been a close call. That’s your clue to give those situations serious thought and decide what would have been your best course of accident avoidance as they happen.

SPECIAL NOTE: WHY IS IT IMPORTANT TO TAKE A TRAINING COURSE?

Here’s an example from the April 07 AMA Magazine. “When I took the MSF Rider Course, the instructor really hammered into us that the most important factor in safety was being constantly aware of your riding environment. Just a few months later as I was traveling down a 4-lane highway at 45 mph, I was in the left lane to turn left a short distance ahead. Directly in front of me was a truck piled high with junk. The training came to mind immediately and I thought to myself that maybe I should back off a bit. Not 10 seconds later, a giant gas grill came tumbling off the truck directly into my path. There was heavy traffic to my left and right. Because I had time to react, I was able to stop safely and avoid a catastrophe. Had I not backed off, I couldn’t have avoided a crash.”
A good example of how staying alert helps you to stay alive.

IMPORTANT INFORMATION FOR CELL PHONES AND YOUR MEDICAL INFO.

ICE (In Case of Emergency) – If involved in an accident, one of the first thing the Medics look for is your cell phone. If you have ICE in your telephone directory, they will have the numbers you specify to call. This is very simple and easy to program. Just as you would program a name and phone #, ICE wife – 999-999-9999, ICE son – 000-000-0000, ICE neighbors, etc. Program in as many as you desire.

EPI (Emergency Patient Information) – This is a free service which will get you a credit card sized I.D. card with a Rescue Login number. Medical personnel can key this number into a computer and your personal information is immediately available to them. This could save your life where time is of extreme importance. Go to www.myepi.net From this website you can complete a form which will include your important personal medical information. Upon completion, you can print a temp. EPI card and will receive a plastic one in the mail. All of this is free of charge. One is recommended for each family member. Don't have a computer? Go to a friend who does and ask them to assist you.
